The transition of the energy system will rely on reducing the overall energy demand and making the energy supply side climate neutral, in current and future climate conditions. R&I actions will help to make the energy supply side **cleaner, more secure, and competitive** by boosting cost performance and reliability of a broad portfolio of renewable energy solutions, in line with societal needs and preferences. Topics under “Sustainable, secure and competitive energy supply” (Horizon Europe, Cluster 5, Destination 3) support this transition and to contribute to the “”, which aims to accelerate the deployment of green technologies.
